

# **Qualification Guide – Close Protection**

Welcome as a learner in the National Certificate: Close Protection. This qualification articulates to the National Diploma: Policing. This means that when learners complete Close Protection (1<sup>st</sup> year) they qualify to register for the National Diploma: Policing (2<sup>nd</sup> year).

#### 1. Entry Requirements

- A grade 12 certificate
- An equivalent NQF Level 4 qualification

#### **Examination Fee**

Examination fees – R200.00 per module per learner AND Re-examination fees – R500.00 per module per learner To be paid May or October.

#### Assessment

The qualification requires learners to conduct formative and summative assessments.

- Formative assessments (assignments) must be submitted and find competent to qualify for examination.
- Summative assessments (assignments) must be submitted and find competent.
- Examinations will be every six months (6) June or October.

#### Formative assessment

Each learner must submit an assignment (formative assessment) for each module.

Summative assessment

Each learner must do a summative assessment (examination) for each module (during June or October).

Examination

Each learner must do an examination for each module (during June or October).

COSTS DO NOT INCLUDE UNIT STANDARDS OUTSOURCED. After successful completion of HJN Training modules (Unit Standards) learners need to complete all 5 OUTSOURCED Unit Standards at an accredited training provider and submit the results to HJN Training.
